What is GDPR?

GDPR is a European Regulation set to **protect, unify and empower EU residents to protect their personal data**. All companies offering goods or services to any EU residents are subject to GDPR, wherever in the world they operate.



The 5 key requirements of GDPR

Easy access to data



Every EU individual has the right to access their data, have it provided in a machine-readable format, and to require rectification or deletion (The right to be forgotten).

Clear Consent & Transparency



Organizations should gain affirmative consent for data collection and processing. Implicit opt in consent is not enough anymore.

Privacy by design & default



Data protection must be an integral component within IT systems and business processes as a default state.

Data breach notification



Organizations need to respond timely, mitigate losses and notify regulators and affected parties.

Transfers based on an adequacy decision



Transfer of personal data to a third country or an international organization may take place only when an adequate level of protection is ensured.

It is used to process data but in a transitory way, meaning that none of the data is permanently stored. Acting as middleware, OL Connect does not create a GDPR breach for its users.

Enabling Customers

OL Connect can take customer requests for information via the web as a trigger to notify internal data operators and automatically present the information in a web, mobile or PDF format in the fastest way possible.

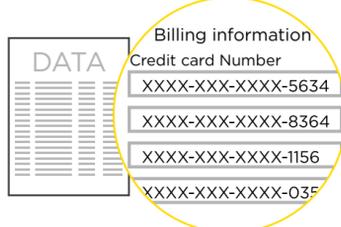


Data Capture & Normalization

OL Connect can automate data capture from any system and then normalize it to provide a single unified data format which can drive ongoing communications.

Data Anonymization

OL Connect can apply rules to any tagged data item. For example, a credit card number captured from a specific system could be reformatted to redact and/or anonymize elements to ensure that it is recognized by the intended recipient only.



Removing Data

Whilst OL Connect does not remove any data from any system, requests to remove data can be automatically sent to specific individuals within an organization to do so.

Data Protection Officers

OL Connect Software can provide web interfaces to data controllers to allow them to monitor incoming requests, review data and then trigger communication processes.
